Official Notice of Annual Meeting

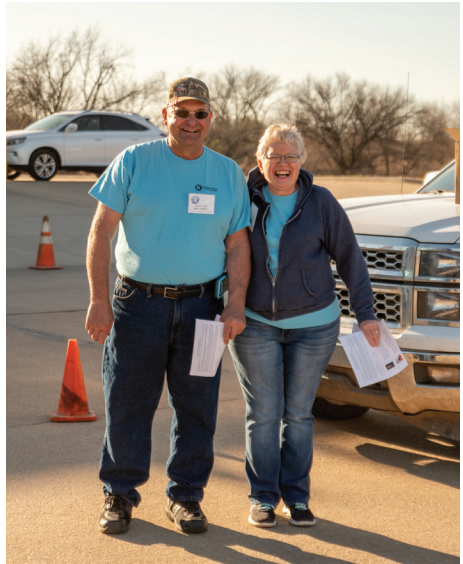

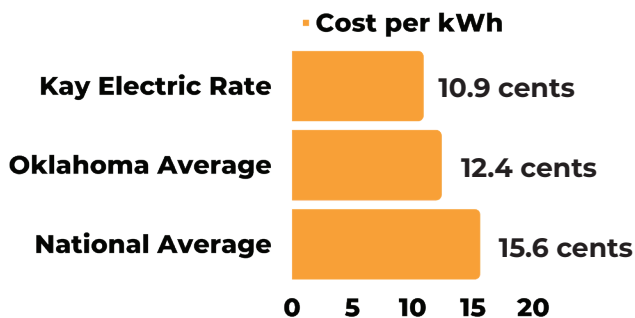
Kay Electric weathered 2022 storms, similar to 2021. Supply chain shortages, spiking fuel costs, and inflation became a new normal during the year. Even with the increased costs of doing business, your electric cooperative continues to operate in an efficient manner. Kay Electric stayed true to its mission, delivering safe, reliable, and affordable electricity to you, our consumer-members. Your Kay Electric employee workforce remains professional and dependable at keeping the power on. They not only get the job done, but they get it done the right way.

The 2021 Storm Uri Polar Vortex event, with blistering cold days to last almost a full week, was eclipsed in total usage by the 2022 December Storm Elliott. Better market

supplies in our regional grid kept the power on this time. Our power provider, Western Farmers, is spreading Storm Uri high fuel costs over five years, and Kay Electric is now in its second year of shouldering half of that cost out of budgeted margins. You won't see many utilities with that type of collaborative approach to problem solving. We've done this while keeping your rates affordable from both a state and national perspective. The Energy Information Administration tracks electricity rates and that data clearly supports our fiscally responsible approach which hasn't had a residential rate increase in 13 years.

Kay Electric continued its robust community support by encouraging area high school juniors to

participate in the essay contest for a chance to win an all-expense-paid trip to Washington, D.C., on the Youth Tour or to Steamboat Springs, Colorado for Leadership Camp. The top eight essays written on electric vehicles were awarded scholarships and cash prizes. First place went to Christian Widener from Blackwell High School and second place went to Carlene Johnson of Garber High School. Area eighth-graders were also included in an essay competition. Kira Widener of Blackwell, Lillie Lewer, Sydnee Benson and Nyla Evans from Garber and Lyrick Horn and Kenna Kilian from Medford were awarded the trip to Hinton, Oklahoma's beautiful Canyon Camp for Energy Camp.

The K-UP Charitable Foundation awarded over \$18,000 in grant funds to area organizations, made available by Kay Electric members and miscellaneous donations. Members can elect to round up their monthly electric bill to the nearest dollar, with the extra funds donated to K-UP.

At home, our inspection and maintenance programs continue to keep the system strong and reliable. Kay Electric crews logged 307,113 miles in our five-county service territory to perform maintenance and work service orders. We inspected 6,584 poles in our annual pole inspection program, across our 2,266 miles of line and 49,274 poles, which identified 193 pole deficiencies for correction. The old maxim "an ounce of prevention is worth a pound of cure" continues to be true. Due diligence to keep the system in good order always pays for itself in the long run and keeps the lights on.

We look forward to seeing you at our annual meeting on Friday, April 14. This will again be a drive-thru style event held at the Kay Electric Headquarters, 300 West Doolin in Blackwell, due to renovations at Blackwell High School.

The trustees and employees at Kay Electric Cooperative thank you for allowing us to serve your energy needs. 🙏

2022 Annual Meeting Minutes

The Annual Meeting of Kay Electric Cooperative was held April 8, 2022, as a drive-thru and Facebook Live event at the Kay Electric headquarters. Members registered, attended and/or participated in accordance with requirements of the cooperative's Bylaws. A quorum was determined to be present. President Max Hohmann called the business meeting to order at 7 p.m.

Ron Shoffner, Secretary/Treasurer, presented the cooperative's current financial report and reported that the Minutes from the 2019 Annual Meeting had been approved during the drive-thru balloting procedure.

CEO Jason Boesch then addressed the membership and recognized the Board, employees, senior staff and Minutemen and women, thanking them for conducting and assisting with a successful, first-ever drive-thru Annual Meeting.

Jon Ihrig, Attorney, addressed the membership and reported that at the meeting of District 8 and District 9, there were no contested nominations for the position of Trustee. Pursuant to the Bylaws, Dr. Tim Blanton from District 8 and Verl Brorsen from District 9 retained their seats on the Board for an additional term. He then recognized Kent McAninch, Trustee representing District 7, who served

on the Board for 37 years and had decided to retire from the Board. Two nominees were selected for election to this position. The two nominees for District 7 Trustee were Bart Cardwell and Andrew McCann. The Credentials Committee had certified the results of the ballots with Bart Cardwell receiving the most votes, and thereby elected.

Mr. Ihrig announced that pursuant to Bylaws Section 3.07, "Nomination and Election of Trustees" in Districts 8 and 9, each incumbent was properly nominated and with no further nominations made, such candidates were declared elected as Trustee without further approval. Those nominated and elected for Trustees were:

District 7: Bart Cardwell
District 8: Dr. Tim Blanton
District 9: Verl Brorsen

Numerous prizes were also awarded and notified by phone at the end of the meeting ending with Richard Reese winning the John Deere pressure washer; Morton Brothers winning the John Deere mower, and Cindy Sebor winning the John Deere Gator. After the grand prize announcement, Board President Max Hohmann adjourned the meeting.

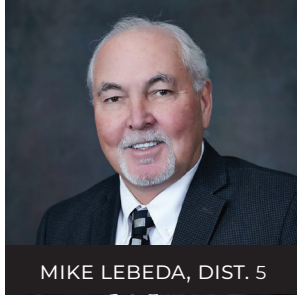

Kay Electric Board of Directors

Kay Electric Cooperative's service territory is divided into nine voting districts. A nine-member Board of Directors represents consumer-members in each district. Kay Electric Board officers are: President, Max Hohmann; Vice President, Verl Brorsen; and Secretary/Treasurer, Ron Shoffner. Trustee positions are up for election every three years.

In February, Districts 1, 2 and 3 held

Trustee elections with incumbent Trustees being re-elected. Any member may run for Trustee, according to qualifications listed in the co-op By-laws, Sec. 4.02. Trustees are required to go through a certification process and must stay informed about electric utility issues and trends. 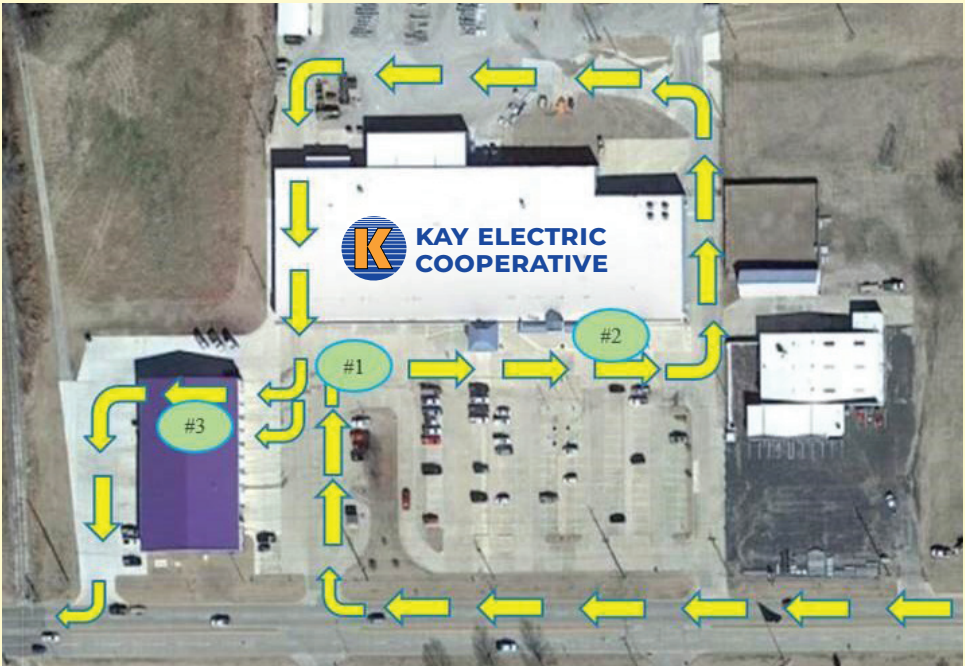
