MESSAGE FROM THE board president & ceo

Year of the Polar Vortex

Kay Electric and its members saw a challenging year in 2021. The year just started when the February Polar Vortex hit from Storm Uri, then came the Covid-19 one year anniversary, and finally inflation closed out the year with supply chain shortages and higher prices. Despite all of this, Kay Electric stayed true to the mission, delivering safe, reliable, and affordable electricity to you our member owner. Weathering these storms wasn't always easy, but a professional and dependable workforce at Kay Electric would not be deterred from reaching our goals.

Much has already been said about the Polar Vortex event, with blistering cold days to last almost a full week. Wind didn't blow for most of that week, leaving wind turbines out of the mix, and solar panels were covered up with snow. Renewables were off the table and then many natural gas pipelines froze up removing gas-fired generation. The limited gas available saw dramatic price increases in the open market. Increased usage to heat homes led to higher demand than available supply. Our fourteen-state grid implemented curtailments for the first time since their 1941 founding. Thankfully our power provider Western Farmers is spreading the high fuel cost from this event over the coming five years, and Kay Electric is also shouldering half of this years added cost from budgeted margins. You won't see an investor-owned utility with that type of collaborative approach to problem solving.

Kay Electric continued its robust community support by accepting 48 area high school junior essays. The top eight essays written on America's past were awarded scholarships and cash prizes. First place went to Hunter Easley from Blackwell High School and second place went to Danielle Buttrum of Garber High School. Area eighth graders were also included in an essay competition, with 65 essays submitted, and the top six winners awarded a Chromebook. The KUP charitable foundation awarded nearly \$24,000 in grant funds to area organizations, made available by Kay Electric member donations and several miscellaneous donations. Members can elect to round up their monthly electric bill to the nearest dollar, with the extra funds donated to the K-UP Foundation.

The 2021 year brought to a close the exemplary 41-year career of Kay Electric Lineman Clinton White with his retirement. The 2021 year saw the third most active Atlantic hurricanes on record, producing 21 storms. Kay Electric sent two crews of six each to Louisiana for restoration aid efforts during Storm Ida. Cooperation among Cooperatives principle was in full effect to aid the Louisiana Electric Co-op DEMCO.

At home, our inspection and maintenance programs continue to keep the system strong and reliable. Kay Electric crews logged 302,540 miles in our five-county service territory to perform maintenance and work service orders. We inspected 5,708 poles in our annual pole inspection program, across our 2,260 miles of line and 49,370 poles, which identified 131 pole deficiencies for correction. The old maxim "an ounce of prevention is worth a pound of cure" continues to be true. Due diligence to keep the system in good order always pays for itself in the long run and keeps the lights on.

We look forward to seeing you at our Annual Meeting on April 8. This will be held at the Kay Electric Headquarters on 300 West Doolin, our first Drive Thru style event due to Covid. The Trustees and employees at Kay Electric Cooperative thank you for allowing us to serve your energy needs.

Kay Electric Cooperative's service territory is divided into nine voting districts. A nine-member board of directors represents consumer-members in each district.

Kay Electric board officers are:

- President, Max Hohmann
- Vice President, Verl Brorsen
- Secretary/Treasurer, Ron Shoffner

Trustee positions are up for election every three years. In February, Districts 8 and 9 held trustee elections with incumbent trustees Dr. Tim Blanton and Verl Brorsen being re-elected. Due to retirement of Trustee Kent McAninch, nominations were received for the District 7 position with Bart Cardwell or Andrew McCann to be elected at the next Annual Meeting. Any member may run for trustee, according to qualifications listed in the co-op bylaws, Sec. 4.02. Trustees are required to go through a certification process and must stay informed about electric utility issues and trends.

KAY ELECTRIC COOPERATIVE 2019 annual meeting minutes

The Annual Meeting was held April 12, 2019 at the Blackwell High School. President Max Hohmann called the meeting to order at 7 p.m.

Ron Shoffner, Secretary/Treasurer, presented the prior year's meeting minutes, which were duly approved. Mr. Shoffner then presented the Cooperative's current financial report and opened the meeting for any questions concerning the printed Treasurer's Report that was mailed to each member.

Jon Ihrig, Attorney, addressed the membership about the nomination process and the bylaw amendment approved by the membership at the 2018 Annual Meeting. Mr. Ihrig reported that the 2019 district meetings were the first conducted under the revised bylaw section 3.07, "Nomination and Election of Trustees". He summarized the 2018 bylaw language allowing for an election to the Board of Trustees at the district meetings under the condition that if only one valid and eligible candidate is nominated and it is evident, after having pursued three times for further nominations and with none forthcoming, that the one eligible candidate is elected without a necessary Annual Meeting vote.

Attorney Jon Ihrig reported upon elections held at the most recent district 7, 8 and 9 meetings. Mr. Ihrig reported that pursuant to bylaws section 3.07, "Nomination and Election of Trustees", each incumbent was properly nominated and with no further nominations made, such candidates were declared elected as Trustee without further approval. Those nominated and elected for Trustees were: District 7: Kent McAninch, District 8: Dr. Tim Blanton and District 9: Verl Brorsen.

The Red Dirt Rangers provided entertainment for the evening. Numerous prizes were also awarded throughout the meeting ending with the Grand Prize of \$1000 which was awarded to Hugh Leven. After the Grand Prize announcement, the meeting was adjourned.
