

### Last winter's Polar Vortex to have minimal impact for KEC's residential consumers

he 2021 February Storm Uri (Polar Vortex) event created unprecedented utility costs in the 14-state Southwest Power Pool region. Kay Electric's power provider Western Farmers Electric Cooperative (WFEC) will begin assessing those increased costs with January 2022 billings. Those costs will be spread across the next five years so as to minimize the impact and prevent any regular monthly bill from being unreasonably excessive.

Kay Electric's portion of increased fuel cost from that event is roughly \$6 million. Utilities in the 14-state region, including Municipalities and Investor Owned Utilities such as OG&E, had mostly the same experience. However, unlike Investor Owned Utilities, where select shareholder profit is a driving factor, Kay Electric is committed to the

needs and welfare of all our members. All of you are consumer-owners at Kay Electric. Therefore Kay Electric intends to shoulder 50% of the increased cost in 2022 out of our margins. We predict the remaining 50% of increased cost will increase residential bills by 1.73%. This means a regular monthly bill of \$100 would be \$101.73.

You will see the increased cost on your bill in the Power Cost Adjustment (PCA) line versus the Energy Charge line. Energy Charge reflects the amount of kWh used multiplied by rate. The PCA reflects the increases or decreases in the cooperative's cost of purchased power from our provider WFEC. The fluctuation is largely determined by changes in the cost of fuel or other materials used in the generation of energy. The PCA is also tied directly to the "Kay Electric is committed to the needs and welfare of all our members...Therefore Kay Electric intends to shoulder 50% of the increased cost in 2022 out of our margins."

Kay Electric will promptly share any changes to this situation should they arise and we will continue to process payment arrangements as needed. As a member-owned cooperative, Kay Electric is committed to cooperatively working our way through this event together with you. That's just how cooperatives work. **K** 

### GOOD **COOKIN'**

### **Texas Cowboy Stew**



#### **Ingredients**

- 1 onion, chopped
- 2 garlic cloves, minced
- 2 pounds ground beef
- 2 packages kielbasa sliced into ½ inch pieces
- 2, 14.5-ounce cans diced tomatoes, drained
- 2 14.5-ounce cans diced tomatoes with green chilies, undrained
- 2, 15-ounce cans pinto or black beans, undrained
- 15-ounce can whole kernel corn, drained
- 4 medium baking potatoes, peeled and diced
- 10-ounce package frozen mixed vegetables
- 4 cups water
- 2 teaspoons ground cumin
- 2 teaspoons chili powder
- Salt and pepper to taste

In a Dutch oven over medium heat, sauteé onion and garlic over medium-low heat. Add ground beef, increase the heat and cook until there's no pink left. Add sliced sausage, tomatoes, beans, corn, potatoes and vegetables. Mix everything until well combined; add spices. Add water, bring to a boil and simmer for 1 hour.
